President Byron Bustos, Board President, called the meeting to order at 7:00 p.m. He said that the meeting is being held in accordance with the "Open Public Meetings Act". The meeting notice was mailed to <u>The Herald News</u>, <u>El Diario</u>, <u>The Record</u> and the presidents of the five employee groups.

E. Communication and Presentation of Bills and Accounts by Secretary

A motion was made to accept the Board Communications and Minutes were approved at the prior meeting.

F. Remarks from the President of the Board

President Bustos thanked the representatives from the scholarship dinner and congratulated School #9 black history presentation. He expressed he is excited about the opening of the new playgrounds at Schools #1 and #10. He reminded the public about the election on April 21st. President Bustos also summarized a letter that he received from a teacher from School 6 about Annie and the history of donating and receiving gifts for children at the credit union.

G. Reports from the Superintendent of Schools

Mr. Muñoz discussed the adoption of the school budget. He provided a highlighted summary of the budget presentation that was presented on March 25, 2015.

H. Public Comment

Ms. Minnie Hiller-Cousins, 368 Highland Ave, thanked the Special Services department for representing her grandson at a meeting. She requested for a paid summer school and wanted to know where the money goes for the vending machines. She feels the money from vending machines could benefit students for graduation and other things for students.

Mr. Joe Conasenti showed pictures of various building and grounds of the Passaic Public Schools that are in need of maintenance.

Mr. Jaroslaw Jackiw, 266 Lafayette Ave, asked the following questions:

- 1) How will the candidates address the security issues that are faced by the student/parents and educators in the current school year of SY 2014/2015?
- 2) The candidates that are running for the Annual School Elections. Will you support a motion when elected to the school board elections: Will you support a motion when elected to the school board to change the passing grade from 65% to 70%? Will you support a motion when elected to tie in students' performance to the annual salaries of administrator/educators in future contractual negotiations?
- 3) When will the BOE/ Office of Human Resources file the missing 2015 school Ethics Commission Disclosure Statements for the Passaic City School District?
- 4) At a special meeting of March 5, 2015 the school board approved the following-Maintenance Reserve withdrawal of \$8 million and Capital Reserve Withdrawal of \$2.6 million.
- 5) How will the Board ensure the community that the state/county/ and city tax payers will receive a bang for their tax dollar?

President Bustos explained that OPRA requests are for existent documents.

Students from Passaic High School have signed a petition to rehire Coach Matos as the track coach. The students wanted to demonstrate the impact he has had on their lives and asked for the rehiring of Coach Matos.

President Bustos that he knows Mr. Matos personally and explains he understands the heavy heart and thanked them for coming to support.

Mr. Rosario thanked the students for coming out and Matos should be proud.

Ms. Angelica Perez- 69 Linden St., explained her discontent with the middle school. She explained that she chose to pull her son from school to be home schooled. She also explained that she is not getting her calls returned. Ms. Perez explained that she was told that she put in too many HIBs and that she feels that she is not getting any help. She feels she was prohibited from filing a HIB investigation.

Public Comment (Continued)

Ms. Maribel Robles explained that her grandson continues to get bullied and explained that she feels the middle school needs change.

Student from LMS,- explained that he continues to be bullied and explained how he feel about the middle school.

Mr. Rosario explained that he cannot legally comment on her questions regarding HIB. He did explain that he has investigated her concerns on four (4) occasions. He explained that he cannot manage the schools.

President Bustos explained that board members set policies and hire administrators.

Mr. Brisman explained the legal framework for the public forum portion of the board meetings.

Ms. Kathy Henley, Grove Street explained her concerns with security and safety at LMS.

Ms. Jennifer Greens explained that her son has been bullied. She expressed her concern about the way her son is being handled by the physical therapists. Ms. Greens explained that her son is not benefitting from the physical therapist that he is working with. She described a verbal altercation she had with the physical therapist. She is worried that something may happen to her son.

Students from PHS- advocated for Mr. Schmitz and requested that he be reinstated to the high school.

President Bustos and Mr. Rosario- thanked the students for coming out and for their service.

Mr. Muñoz addressed items that were brought up. He will follow up about the vending machines and where the revenue goes and explained the district will not charge for summer school. Mr. Muñoz thanked the community for the pictures. He also explained that the board adopts an annual Comprehensive Maintenance Plan and that maintenance projects are prioritized. He commented School Ethics Commission submittal due date is in April; therefore, nothing is missing thus far. There are measures in place for accountability and management oversight as well as NJQSAC. The budget is also reviewed on a semi-annual basis.

Mr. Muñoz explained the process for hiring coaches and the Director and Supervisor of Athletics are charged with developing a winning program. HIB-after every meeting, the district has a statutory obligation to conduct a HIB investigation and the board approves the cases on a monthly basis. Parents also receive letters once the investigation is complete and board approved. He explained the definition of the law of the HIB and conflict. He noted parents are entitled to have a hearing if they do not agree with the finding. He also commented special education students have state and federal laws that offer protections for them.

Mr. Muñoz explained that the number of security members have increased and will continue to increase into next year. He explained that Mr. Naji and his team have provided positive changes and asked Mr. Naji to explain some of those changes. He explained the steps in dealing with allegations and personnel.

Mr. Naji, Principal of Lincoln Middle School, instituted random wandering and increased patrolling throughout the school in an effort with the police department, Coordinator of Security and security aides. He has increased central and Saturday detention for disciplinary to reduce the number of suspension. The character education program and assemblies were provided and increased the number of clubs and after school activities. The district hired a new parent liaison and increased parent workshops. Overall, the school is clean. Goal is to address all concerns and focus on instruction.

Mr. Carrera asked what measures are in place for students that are problematic.

Mr. Naji provided what steps are in place to address the needs of the students based on academics and behaviors.
