Mr. Muñoz presented event highlights for the following schools: 3, 5, 7, 11, 16, 19, Lincoln Middle School, and Passaic High School

District should look into live taping of meetings to air on local cable station so residents who are not able to attend can view.

(President Diaz - board used to record meetings previously - does not know why it was stopped / Mr. Patel responded that more information will follow regarding alternate route, one of goals of this board is more transparency and getting more of the public to the board meetings)

Ruth Rangel (Parent), 57 Poplar Street, 2nd Floor

Regarding her child's SPED services (therapy was discontinued in school) but her doctor has informed her that therapy is still needed and she is taking the child out of school weekly for therapy.

Absences - should be excused as they were due to doctor's appointments / when child comes in 10 -15 minutes late due to appointments he is not accepted.

Question regarding fund raising policies/school functions -should be the same rules for all schools - some schools have functions others are told no.

(Mr. Muñoz advised her to make an appointment with Ms. Pagan to discuss the absences and school functions issues and Ms. Goldberg to discuss the special services issues). Mr. Muñoz explained that policies govern school functions and there are rules regarding absences.
